### **Planning**

Demand Analysis and Design Development for pavilion(s) and amenities - E. Apeldoorn

- Received 8 submissions for the RFQ for the concept design development for the new pavilion and storage units.
- Contract awarded to H+H Architects, based in Bunbury.
- Currently planning kick off meeting for the project.
- Three concept sketches will be drafted and then a workshop between the architect and the stakeholders will be held.

# Traffic Report - E. Apeldoorn

## Playing Fields Analysis & Design – E. Apeldoorn

- Geotechnical Study minor corrections have been made to the report and the final report has been received. This will be emailed out to the committee.
- Agronomy Report will be emailed out to the committee.
- Water Supply Irrigation Strategy currently working on the draft report.
  Looking at the current capacity of the dams and the water quality.
- Playing field's layout (workshop) discussion regarding the proposed layout of the fields at the Reserve. Draft to be provided to the stakeholders for comment. Field layout must be confirmed soon so that the light pole locations can be confirmed.

Power Upgrade and Field Lighting Project Update - E. Apeldoorn

- The power upgrade needs to be progressed as soon as possible in order to meet grant timelines.
