Strategic Plan and Corporate Business Plan

At the Council meeting held on Thursday 17 June 2021 Council adopted the Strategic Community Plan 2021-2031 and Corporate Business Plan 2021-2025.

The Strategic Community Plan captures and outlines the Shire community's long-term (10 year +) vision, values, aspirations and priorities with reference to other Shire of Maniimup and plans, State Federal Government plans, information resourcing capability. Its priorities and goals have been driven by community engagement and it takes a 'whole of shire' approach.

The Corporate Business Plan is an internal planning tool that translates Council and the community's priorities defined in the Strategic Community Plan into operational activities to be completed by the local government administration. The plan details

the services, operations and projects the will be undertaken over two years, from July Shire will deliver within the next four years. It also includes the processes for delivering these and the estimated costs associated.

Youth Engagement

Recent grant funding from Foundation for Rural Regional Renewal Tackling Tough Times Criminal Together (\$60,000), and the Confiscation Grants Program (\$95,053), along with \$41,074 from the Shire of Manjimup, has enabled the Shire to commit to a Youth Engage and Empower

The project aims to support youth mental health and resilience, assist youth to develop sense of community belonging and engagement, develop leadership and life skills and support the development of the local youth services sector.

The project is a collaboration between the Shire of Manjimup, youth groups, schools and youth agencies and focuses on young people from the age of 12 upwards to 25 years old within the Shire of Manjimup. The project

The State's Valuer General sets values used to calculate individual rates according to the Gross Rental Value (GRV) a property could raise if rented. In many country areas, unimproved values (UV) are used according to land value



How other charges affect rates Services Councils pay for, such as street lighting, are often subject to price increases. These costs are passed on to councils which increases budget requirements. which in turn increases rates



affect rates

Councils strive to meet community requests for new facilities such as recreation centres, increasing Council budget requirements, which will be recovered through rates



Home improvements can affect rates

If the comparative value of your home increases through renovations or an extension, the share of Council budget you pay in rates may increase



How costs of services affect rates

Did you know your rates may also pay for Council security vehicles, seniors programs, disability access and inclusion programs, rangers, community events, waste services and health inspections?



Housing market movements do not affect rates

General changes in the Western Australian housing market have no impact on your comparative share of rates, due to all properties being affected.



How community facilities affect rates

The local community determines priorities for services and facilities, which impact upon Council budget requirements, which in turn, increases rates
