Strategic Plan and Corporate **Business Plan**

At the Council meeting held on Thursday 17 June 2021 Council adopted the Strategic Community Plan 2021-2031 and the Corporate Business Plan 2021-2025.

The Strategic Community Plan captures and outlines the Shire community's longvalues. (10 year +) vision, aspirations and priorities with reference to other Shire of Manjimup plans, State Federal Government plans, information and resourcing capability. Its priorities and goals have been driven by community engagement and it takes a 'whole of shire' approach.

The Corporate Business Plan is an internal planning tool that translates Council and the community's priorities defined in the Strategic Community Plan operational activities be to

completed by the local administration. The plan details the services, operations and projects the Shire will deliver within the next four years. It also includes the processes for delivering these and the estimated costs associated.

Youth Engagement

Recent grant funding from Foundation for Rural Regional Renewal Tackling Tough Times Together (\$60,000), and the Criminal Property Confiscation Grants Program (\$95,053), along with \$41,074 from the Shire of Manjimup, has enabled the Shire to commit to a Youth Engage and Empower Project.

The project aims to support youth mental health and resilience, assist youth to develop a sense of community belonging and engagement, develop leadership life skills and support the development of the local youth services sector.

The project is a collaboration between the Shire of Manjimup, youth groups, schools and youth agencies and focuses on young people from the age of 12

government upwards to 25 years old within the Shire of Manjimup. The project will be undertaken over two years, from July 2021 till June 2023, led by a full time project facilitator for which recruitment has commenced.

How a boom can affect rates During a boom, Councils increas employee wages to retain staff in a competitive jobs market, increasing budget requirements, which is to be recovered through rates.



How other charges affect rates Services Councils pay for, such as street lighting, are often subject to price increases. These costs are passed on to councils which increases budget requirements, which in turn increases rates



affect rates If the comparative value of your home increases through renovations or an extension, the share of Council budget you pay in rates may increase.



do not affect rates General changes in the Western Australian housing market have no impact on your comparative share of rates, due to all properties being affected.



Property rental values are independently set

The State's Valuer General sets values used to calculate individual rates according to the Gross Rental Value (GRV) a property could raise if rented. In many country areas, unimproved values (UV) are used according to land value.
