

Executive Summary

Key to the Community Safety and Crime Prevention Plan review is a partnership approach in which communities and government work together to identify priority safety and crime issues.

Incorporated into the revised Community Safety Plan is a Local Priority Action Plan. The Action Plan has been derived through on-going community consultation and forums involving state government agencies, various community organisations and the Shire of Manjimup community. The Shire of Manjimup Community Safety Plan 2016 - 2020 will provide a documented structure for a range of strategies and provide a framework to aid stakeholders in developing and implementing initiatives to advance to a safer community over the next five years. As a result of the consultation process and utilisation of Western Australia Police crime statistics (including local statistics, long-term trends and demographic information) several issues were identified that can be grouped into the following five priority areas of drugs, alcohol, road deaths/injuries, mental health and community services. These five priority areas of concern are the focus of the reviewed Action Plan, which now includes the continuation of results-proven projects as well as the implementation of various new projects which address existing and emerging issues.



1. Introduction

It is the view of state government that, as the tier of government closest to the community, local government is well placed to assist *Community Safety & Crime Prevention* partnerships by facilitating the development of a local strategic plan and 'housing' the plan on behalf of the local community. Therefore in August 2005 the Shire of Manjimup entered into a partnership with the Western Australia Office of Crime Prevention as part of a new state government initiative for reducing crime and improving community safety.

Key to the strategy is a partnership approach in which communities, local government, Western Australia Police and other government agencies work together to identify priority community safety and crime issues, find local solutions and develop these strategies into a Community Safety Plan. To ensure the Community Safety Plan remains functional and relevant the aim is to update the previous plan (adopted in 2011) and create the Shire of Manjimup Community Safety Plan 2016 – 2020 (CS&CPP). The 2016 – 2020 plan is a substantially reviewed document with the expectation that it would be a more succinct and usable, living document. The days of writing 60 – 80 page long community safety plans is a philosophy of the past.

The Community Safety & Crime Prevention Review project aims to undertake a comprehensive review through;

- Analysis of available statistical data produced by relevant government and community organisations;
- Continuing to survey community attitudes and perceptions of crime within each town/district:
- Address community concerns in relation to safety & crime with program/ strategy implementation;
 and
- Develop a local *Community Safety Plan* based on addressing those priority issues.

Crime and safety issues more often than not indicate wider underlying social, economic and community health problems such as unemployment and abuse of alcohol, drugs and other substances. Because of the breadth of problems a holistic community approach is required. Community safety strategies involve activities, projects and programs relating to the direct reduction of criminal events as well as to various "quality of life" issues such as the fear of crime. These actions will be a component of the CS&CPP and will encompass a wide range of projects and activities being delivered by a diverse range of government agencies, key stakeholders and community groups in partnership with the broader community.

Consultation with the community and key stakeholders has resulted in important and relevant feedback regarding experiences and perceptions of community safety and crime prevention. Two broad approaches inform the design of crime prevention strategies and have been utilised in the development of the CS&CP action plan:

1. <u>Situational crime prevention</u> reduces the risk of, and opportunities for, crime by the systematic management, design and manipulation of the immediate physical environment in which crime occurs or is likely to occur.

2. <u>Social crime and violence prevention</u> deals with the underlying motivational causes of criminal and antisocial behaviour and focuses on increasing social inclusion and promoting opportunities for law abiding behaviour.

2. Background

2.1 Demographics

2.1.1 Land Use




Figure 1: Shire of Manjimup (Source: ABS Census 2011: LGA 2013)

The Shire of Manjimup, shown in Figure 1, is the largest geographical Shire in the South West of Western Australia, covering 7026 square kilometres. Eighty-three percent of the Shire is composed of National Park and state forestry. The Shire's natural landscape comprises great rivers, unique forests and more than 140km of pristine, spectacular coastline which offer a number of diverse attractions and experiences for tourism. The timber industry, largely responsible for the non-indigenous settlement and development of the region, has had an indelible impact on the local economy and identity for more than 100 years.

The remaining land is predominantly used for agriculture and the region is known for its production of wine, truffles, avocados and other vegetables, fruit and nuts. It also boasts many marron farms and some traditional livestock, predominantly cattle and dairy herds.

2.1.2 Population

According to 2011 Census figures, 9,183 people live within the Shire boundaries, which is a reduction from the 10,159 residents recorded at the previous Census count (2006). The population of the Shire is both diverse and dispersed. Most WA local government authorities have their population based predominantly in one or two main towns; the Shire of Manjimup has four main population centres (from largest to smallest):

- 1. Manjimup
- 2. Pemberton located 33km southwest of Manjimup
- 3. Walpole located 120km southeast of Manjimup.
- 4. Northcliffe located 55km south of Manjimup

In addition to these town sites the Shire also has seven populated settlements:

- 1. Palgarup
- 2. Deanmill
- 3. Jardee
- 4. Quinninup
- 5. Windy Harbour
- 6. Nyamup
- 7. Tone River

The Shire of Manjimup's population is ageing, reflecting not just a state wide but worldwide trend. In 1996 just 17.0% of the Shire's population was aged 55 and over. In 2001 this had increased to 20.3% and by the 2006 Census had grown to 25.5%. Over this same ten year period the Shire's total population declined by 7.6%, down from 10,020 in 1996 to 9,255 in 2006 while the population in the 55 and over age group increased by 649 people (a 38% increase). The Manjimup SuperTown planning projects population growth for Manjimup to double by 2032.

2.1.3 Socio-Economic Status & Employment

According to the Australian Bureau of Statistics Socio-Economic Indexes for Areas (SEIFA), the Shire of Manjimup has a relatively high level of socio-disadvantage, with a SEIFA score of 946 at the 2011 Census compared to the national mean SEIFA score of 1000. Furthermore the Shire of Manjimup ranks 213 out of 565 LGAs across Australia and 30 out of 139 in WA.

The unemployment rate within the Shire in 2010 was 4.4% and the average taxable income (of both taxable and non-taxable individuals) was \$36,047.

It has long been known that officially recorded rates of most forms of crime are higher in economically disadvantaged areas. There is a very clear relationship between socio-economic factors and crime (Aust. Institute of Crime 1998) putting the residents of the Shire of Manjimup at an elevated risk of experiencing or being exposed to criminal or illegal activities.

2.2 Community Crime Profile Data

The Western Australia Police publish statistics for a broad range of offence categories at the state, region and district levels. This crime data can provide benefits for community safety planning. These include identifying problem localities, problem categories and trends in crime data. They also provide an indication of the success of crime safety or crime reduction strategies. However, there are limitations with recorded crime data that need to be recognised. These include:

- Crime data reflects crime reported to police. However, not all crimes are reported to police.
- Increases in reported crime can mean many things and may not reflect that
 more crime is occurring. It may mean a greater willingness for people to report
 crime or successful marketing and advertising campaigns encouraging people
 to report crime.
- Increases in reported crime may reflect increased activity by one or a number of offenders. If those offenders are removed, crime rates change considerably.
- There can be a significant time lag between collecting, analysing and publicising crime data.
- Recorded crime data do not provide information about police clearance rates or successful prosecutions.

Limitations aside, there are benefits in tracking crime statistics. The tables below show the number of reported offences by offence type in each of the towns in the Shire of Manjimup over the years 2010 to 2014. The tables show Assault and Burglary as being the most prolific crimes being committed in the Shire of Manjimup, though interestingly there have been no reports of robbery in any town within the past 5 years.

3. Methodology

3.1 Update of existing Plan

The process of updating the existing Shire of Manjimup Community Safety Plan (2011 – 2014) has included analysis of crime data supplied by the Western Australia Police, feedback from local community members and input from key stakeholders. This has enabled the identification of issues, strategies and partnerships including those shared responsibilities required to address the agreed priorities.

3.1.1 Community Safety and Crime Prevention Workshops

Workshops were convened at each town during May 2014 for the purpose of presenting crime data, identifying issues, obtaining insight in the perception and input into the prioritisation of issues and reviewing current strategies. The workshops also provided opportunities for the development of new initiatives and strategies.

3.1.2 Community Safety Survey

An online survey was developed to elicit input from community members who may have been unable to, or did not wish to, attend the community workshops. The survey was linked to the Shire of Manjimup website during the latter half of 2014 and participation by community members was invited through the Shire website, newspaper advertising, network sharing and via posters on public noticeboards. There was minimal uptake of the online survey, with only 7 responses received. This poor response may have been due to several factors include this being the first time the Shire had used this avenue of information collection.

3.1.3 Community Satisfaction Study

In 2014 Council engaged Corporate and Regional Enterprise to carry out its fourth Community Satisfaction Study, largely replicating the approach used in the 2011 Study. A self-administered questionnaire was distributed by post to a random sample of households within the Shire. A total of 2,000 questionnaires were distributed. Of these, 345 questionnaires (17.3%) were returned. Just over half (55%) of the respondents were female and almost two-thirds (62%) of the respondents were aged 55 years and over.

3.2 Stakeholders Consulted

To ensure opportunity for extensive representation throughout the community, one month prior to the community workshops 177 invitations were sent to stakeholder groups and individuals. Groups targeted included sporting clubs, community groups, resource centres and schools. Public invitations were published in the Manjimup Bridgetown Times, Walpole Weekly, Pemberton Community News and Karri Pigeon. Flyers were posted on public notice boards, in libraries, Community Resource Centres, sent through Network Groups and published on the Shire website. The extensive advertising was undertaken to ensure that all in the community had opportunity to put their view forward and have input into the review of the Community Safety Plan.

The workshops were held in each town during May 2014. Members of the public attended the workshops along with representatives from the following groups and organisations:

4. Results of Community Consultation

An overview of the matters raised during the four community workshops held in May 2014 is included in Appendix A. This appendix also provides a summary of the outcomes of the online Community Safety Survey and the Community Satisfaction Survey. The findings of the community workshops, the online Community Safety Survey and the Community Satisfaction Survey, and the common themes presenting in the community concerns have been grouped and summarised under four categories:

Drugs & Alcohol

Drugs and Alcohol have been grouped together as research shows that there is a direct relationship between alcohol consumption and drug use. Community concern revolved around incidents of anti-social behaviour and vandalism as a direct result of alcohol and drug misuse throughout the wider community.

Mental Health

The lack of support for persons and families with mental health issues. The increase of mental health issues resulting from drug taking.

Road Safety

Visitors and backpackers endangering themselves and locals through their inexperience and lack of understanding of the skills required for country driving versus city or suburban driving.

Community Development

Promotion of a positive culture underpinned by town planning, education and employment opportunities. It is recognised that community development is a whole of community issue and not the Shire of Maniimup's alone.

An Action Plan has been developed to address identified community concerns within these four categories which can be found on page 13. The Action Plan provides strategies for addressing concerns and suggests outcomes against which to measure change. Most notably there been the change in community concern bringing 'Drugs' to the fore and prompting expansion of the Manjimup Alcohol Management Plan to become the Manjimup Alcohol and Other Drug Management Plan.

5. Action Plan

The CSCP aim is to address issues raised by the community in pursuit of a safe community, where people are able to live without fear or hindrance from crime and disorder. It is recognised that this is a long term vision with tangible results not always being immediately obvious. Aspects of the plan are long term strategies aimed at initiating and supporting cultural change and although it is evident that they will not yield measurable results for a significant period of time it is a goal well worth pursuing.

6. Implementation

The aim is to address each of the priority issues using a partnered approach with key stakeholders and the community during the next five years. As custodian of the Community Safety Plan and with the cessation of the Community Safety Committee (more background information provided in the following paragraph.), the Shire of Manjimup instigates reviews of the CSCP at appropriate intervals.

6.1 Community Safety Committee

A Community Safety Committee was formed with the implementation of the initial Community Safety Plan in 2007. The committee now ceases to operate due to the formation of the Manjimup Alcohol Management Plan (MAMP). The MAMP encompassed a high proportion of the actions recommended for implemented in the CS&CPP and became the furthermost relevant plan to address the community's issues. Several of the CS&CPP committee members now sit on the Manjimup Alcohol Management Plan Committee. The Committee through the Alcohol Management Plan aims to prevent harmful drinking and reduce alcohol-related harm in the Shire of Manjimup community. AMP Committee membership is a partnership between The Shire of Manjimup, Dept. of Mental Health (whom the Drug and Alcohol Office now sit under), Western Australian Country Health Services, St John of God and includes key community groups such as Red Cross and D.O.V.E.S. Currently the plan is being expanded to include 'Other Drugs' which have been specifically identified as Cannabis and Methamphetamine.

6.2 Funding/Resources

The Office of Crime Prevention no longer grants specific funding to implement or resource local government Community Safety and Crime Prevention Plans. Funding to run the AMP and implement projects is either 'in kind' through stakeholders or grant funded. Grant funding for activities or programs can be sourced through several providers but as with funds sought for any project, grant funding is highly competitive. The Shire of Manjimup currently provides funding to aid in the implementation of the Community Safety Plan.

6.3 Evaluation and Review

The Community Safety Plan and Community Action Plan will be living documents requiring regular review, instigated by the Shire and contributed to by stakeholders and community members to ensure they remain current and relevant.
