

# 10.2 <u>PARKS AND GARDENS</u> Standard of Maintenance for Parks Assets Within the Shire

#### Background & Issues

10.2.2

Parks and reserves (also known as Public Open Space) in the Shire of Manjimup provide many advantages: formal and informal sport and recreation, preservation of natural environments, provision of green space and even urban storm water management. Well managed and maintained parks and reserves also benefit our community with improved physical health and wellbeing, improved quality of life and long term health, improved mental health, reduced healthcare costs and enhanced social outcomes such as reducing crime and social dysfunction.

Council makes a significant investment into the development and maintenance of streetscapes, sporting reserves, playgrounds, and other parks infrastructure. While the result of Council's investment into capital projects is obvious, the value Council receives for its maintenance expenditure is not so clear. The setting of a standard, commensurate with the budget, provides a clear statement of the application of Council's parks maintenance investment. In addition, with increasing higher level government pressure to adopt service levels for assets, along with pressure to adopt asset management plans, adopting a standard of maintenance will ensure Council is able to comply with future statutory and grant condition requirements.

## **Objectives**

To ensure an appropriate standard of maintenance and Level of Service (LOS) for Parks and Gardens infrastructure within the Shire.

The Policy will also provide a basis for determining the required budget when asset expansion occurs (usually through subdivision development or capital investment), and enable the Shire to control the expenditure of its maintenance investment through adjusting the LOS to suit the desires of the community weighed up against the Council's overall capacity to pay.

## **Area of Application**

Funded park's infrastructure within the whole of the Shire.

### **Policy Measures**

To maintain public open space in accordance with priority and Category of POS, as per Appendix A, attached.

#### **Administration**

Implementation of this policy will be by the Manager of Park and Gardens.
