Cat Owner Responsibilities and Important Information

- Cats six (6) months and over **must** be registered, sterilised and microchipped with the Sterilisation certificate sighted and copied by the Shire, or the below Statutory Declaration must be signed together with exemption documentation supplied as proof.
- There is a penalty for failing to register your cat(s).
- If registering prior to (6) months of age you **must** supply a pre-paid receipt from your Vet for microchipping and sterilisation.
- The Shire must be informed immediately in writing or by email of any change in ownership, the death of a Cat and any change of address.
- Current pension cards are to be shown each time the pension concession is claimed. 50% discount applies.
- Cats must at all times wear a current registration tag attached to their collar, this will assist us to reunite you with your cat should it become lost.

Shire of Manjimup Cat Local Laws 2021

2.1 Cats in public places

- (1) A cat shall not be permitted in a public place, if in the opinion of an authorised person, the cat is causing a nuisance.

2.2 Cats in other places

A cat shall not be in any place that is not a public place if-

- (a) Consent to it being there has not been given by the occupier, or a person authorised to consent on behalf of the occupier; and/or
- (b) The cat, in the opinion of an authorised person, is causing a nuisance.

2.3 Cat in prohibited areas

- (1) a cat shall not be in any Cat Prohibited Area as identified in Schedule 3 of Shire of Manjimup Cat Local Laws 2021. Map found on Shire of Manjimup website.
