<ul style="list-style-type: none"> Dogs three (3) months and over must be registered and microchipped at all times. Providing a microchip number is compulsory for all New dog registrations. The Shire must be informed immediately in writing or by email of any change in ownership, the death of a dog and any change of address. Proof of sterilisation is needed to claim the Sterilised rate. Eg Sterilisation Certificate. Current pension cards are to be shown each time the pension concession is claimed. 50% discount applies. There is a penalty for failing to register your dog(s). If registering a dangerous or restricted breed dog, you must contact Rangers at the Shire for more information. Please report lost dogs to Ranger Services 9771 7777. 	<p style="text-align: center;"><u>Dog Act 1976</u></p> <p>31. Control of dogs in certain public places</p> <p>(1) A dog shall not be in a public place unless it is-</p> <p>a. Held by a person who is capable of controlling the dog; or</p> <p>b. Securely tethered for a temporary purpose.</p> <p>38. Nuisance dogs</p> <p>(1) For the purposes of this section, a dog is a nuisance if the dog-</p> <p>a. Makes a noise, by barking or otherwise, that persistently occurs or continues to such a degree or extent that it unreasonably interferes with the peace, comfort or convenience of any person in any place.</p>

RESTRICTED BREEDS - **Must be Sterilised

- Pit Bull Terrier or American Pit Bull Terrier breed;
- Fila Brasileiro (Brazilian fighting dog);
- Japanese Tose;
- Any other breed of dog the importation of which is prohibited absolutely by *Customs (Prohibited Imports) Regulations 1956 of the Commonwealth*, and includes any dog of a mixed breed which visibly contains any of the above breeds.
- Dogo (Argentinian fighting dog);
- Perro Depresa Canario.
