6. UPDATES

Concept Master Plan and Traffic Report

- Plan was presented to Senior Management Team and Council. They support the master plan in principle, but would like further development of costings to ensure it is financially feasible prior to going to public comment.
- Request for Quote for Playing Fields Analysis and Design is going out this week.
- Council and SMT asked for the Master Plan to be simplified to include only the proposed redevelopment and remove future plans (show the reserved space only).
- Awaiting consultant's updated traffic report.

RFQ Playing Fields Analysis & Design

- Scope of works will include four stages – site analysis, site assessment, design development and concept design for new multi-purpose field.
- PO asked how long the process would take. Some funding may become available for community development through the Native Forest Transition Package. It is important for these projects to be shovel ready. EA advised that it is not expected to take an extensively long time.
- JJ asked whether photos would be provided to contractor to show the extent of the drainage issues. EA advised that these would be provided.

Building Inspection Reports

- Tigers Pavilion, Ag Society/Lions Club Pavilion, Warren Arts & Craft Building inspection reports have been received. These have been forwarded to the clubs.

- The reports outline recommendations for improvements, costs to replace or bring up to standard and expected life span of each building.
- JJ mentioned that the Tigers report detailed the requirement for a fire wall between the Tigers and Lions club rooms. EA explained that fire protection systems will be a major consideration of the redevelopment.

Demand Analysis and Design Development for pavilion(s) and amenities

- Report is in draft form to start the discussion with stakeholders. This should be taken back to clubs to review and provide comment. The report will be given to a drafts person to develop a concept design and provide costings.
- EA presented the draft report to the committee.
- Initial discussion about Ag Society/Lions Club Pavilion. EA said the document does include some considerations to be made for this facility. PM was concerned that if the Lions building were gone then there wouldn't be enough storage for the annual event. EA said that there is opportunity to ensure that design of the new amenities can accommodate the current needs of the Reserve users, for example a tiered grandstand located next to the existing Tigers pavilion could include a large, internal display space underneath.
- High level project cost including all components is approximately \$15M at this stage.
- Once final details are included the report it will be sent out to each club individually for a response from each sport.
- JJ asked whether funding could be accessed for upgrades to existing amenities could to ensure they fit into the upgraded Reserve. EA responded there is a possibility that this can occur if the existing amenities are being upgraded to accommodate the needs of multiple users (eg. creation of a meeting space).
- JJ presented a new concept for the Tigers and Lions pavilions, which included a grandstand, space for community activities such as karate/dance, public toilets, and community use meeting rooms. JJ would like an opportunity to put together a concept plan prior to going to design consultant.

Updates from committee members/clubs

- Soccer (TR)
 - Soccer is happy to proceed with the process.
 - Football West have recently released some additional guidelines which may be useful.
- Cricket (JJ)
 - Cricket season has a couple of rounds left and the association has been discussing bringing the end of the season forward due to the current COVID environment. Now that the quarantine requirements have been reduced it is likely the season will remain as is.
 - The lack of shelter at Collier Street has been very noticeable due to the hot weather that we have been experiencing.
 - Cricket nets can't be used when it has been raining, which means the cover over the nets is imperative.
 - Parks are fixing a sprinkler on the turf wicket.
- Football (MJ)
 - Tigers have not met since the previous Advisory Committee meeting but as the season nears meetings will ramp up and project plans will be discussed.
 - Hosting the Black Dog Ride on 19 March.

7. BUSINESS ARISING FROM MINUTES

Club Night Lights Program grant application

- Application submitted for new field lighting, and electrical upgrade.
- Awaiting outcome of application in February 2022.
